Fellowship is the highest accolade that the ICB can bestow upon a member. It is only conferred on members who can demonstrate that they have achieved the highest standards in their career and are able to prove their professionalism, dedication to the principles of bookkeeping, and support for the ICB.

This application form for election to the grade of Fellow should be completed by a full Member, Certified Bookkeeper, who:

- 1. Has been a full Member of good standing for a minimum period of two years immediately prior to the date of this application.
- 2. Has achieved, or has been granted exemption from, all ICB qualifications up to Level IV.
- 3. Has worked as a bookkeeper for a minimum of five years immediately prior to this application.
- 4. Can nominate referees in support of the application.
- 5. Has demonstrated a positive contribution to the ICB.
- 6. Undertakes to actively support and promote the values and objectives of the ICB.
- 7. Is a valuable member of society as a whole.

If the information contained in your application meets the criteria for election to Fellow, the ICB will take up the references. The application form, together with the references, will be forwarded to the Board of Fellows. At this stage you will be invited to attend for interview. The interview panel will comprise Directors of the ICB and members of the Board of Fellows. The interview will normally take place at the ICB offices in London and you will be asked to talk about yourself, your career, what Fellowship means to you, your view of the ICB and how you feel you can work with the ICB in the future.

### Notes to assist you in the completion of the form.

- 1. Reasons for becoming a Fellow: Explain why you feel you would be an ideal candidate for fellowship. How you have developed your bookkeeping career, how the ICB membership has helped you, what you have contributed to the ICB and what you feel you can do in the future.
- 2. Professional Career: Provide an overview of your career, including non-bookkeeping work if applicable; explain why you became a bookkeeper, detail where you worked and the dates. Mention any memorable achievements including non-bookkeeping ones.
- 3. Professional Referees: Provide details of two professionals, preferably Chartered Accountants, to whom the ICB can write to support your application. Please ensure you inform the referee that you are putting their name forward and that they are happy for you to do so. It is most useful for the ICB if the referee feels able to write freely about you and your bookkeeping abilities.
- 4. **Personal Referee:** Provide details of someone who has known you for a minimum of five years. They will be asked to write about you on a personal level: discussing what you may have done in the local community such as charity or voluntary work but generally explaining why they feel you are an ideal candidate for fellowship.
- 5. Declarations: Read all of the declarations and tick the appropriate boxes. Should you need to answer yes to any of the questions please provide full information on a separate sheet of paper. Please read the ICB's policy on Bankruptcy and Convictions and ensure you include all necessary information to assist the ICB in its decision.
- 6. Payment: Provide payment by either cheque or credit/debit card. Please note that the £100.00 application fee is non-refundable. Should the ICB reach the decision not to proceed with your application before the interview stage you will be refunded £50.00 of the application fee.
